Conditions of Publication

- 1. The conditions set out herein constitute the Conditions of Publication. These Conditions refer and apply to any notes, articles, reviews, books, drawings, announcements and background information including, but not limited to, text, drawings, photographic images, designs, figures or tables in any form submitted for publication or published by the Narrow Gauge Railway Society Company Limited by Guarantee (United Kingdom Company No.9925208), its successors and assigns ('NGRS') in whatever form including, inter alia, print, online content, email, feeds and third party content syndication. The following general terms came into effect on 1st May 2015 and supersede and cancel all previous terms and conditions whether formal, informal, written or oral.
- 2. Any contribution for publication, together with all updates, revisions and additions and any subsequent contributions, made to the NGRS ('the **Contribution**') by the same author ('the **Contributor**') is accepted subject to the terms and conditions set out herein as the Conditions of Publication. By submitting a Contribution to an official of the NGRS in any form whatever, a Contributor will be deemed to have accepted these terms and conditions in this Conditions of Publication. The Contributor acknowledges that the legal form of NGRS may at some time in the future change, and such change shall in no way affect any Contribution made under these Conditions, title to which may be transferred to such successor organisation at the discretion of the NGRS.
- 3. Words imparting the singular include the plural and vice versa and words imparting the male include the female and vice versa where the context requires.
- 4. The Intellectual Property in the Contribution offered for publication shall remain vested in the Contributor, but the Contributor hereby grants to the NGRS a worldwide, irrevocable, perpetual, royalty-free, non-exclusive licence to:
 - a. Copy, publish, reproduce, distribute, display, store and retain the Contribution in all forms, formats and media whether now known or hereafter developed (including without limitation in print, digital and electronic form) throughout the world for the benefit of the NGRS (but not to the disadvantage of the Contributor).;
 - b. Edit the Contribution, create adaptations, summaries or extracts of the Contribution and/ or produce other derivative works based on the Contribution, translate into other languages and exercise all of the rights set forth herein in such translations, adaptations, summaries, extracts and derivative works; and
 - c. License others to do any or all of the herein for the benefit of the NGRS (but not to the detriment of the Contributor) and the licence hereby granted shall be assignable to third parties with the consent of the Parties (Contributor and NGRS) which shall not be unreasonably withheld.
- 5. Such licence shall continue to subsist notwithstanding the modification, termination or expiry of this agreement or the NGRS, or the death or disability of the Contributor. The Contributor shall not be liable to the NGRS or any sublicensee for any use of the Material for any purpose other than that for which the same was prepared or provided by the Contributor.
- 6. Ownership of any copyright in the Contribution shall remain with the Contributor.
- The Contributor shall retain the non-exclusive right to re-use any text, drawings, photographs, designs, figures or tables created by them and contained in the Contribution in other works created by them.
- 8. The Contributor warrants and represents that:
 - a. He is the sole author of and sole owner of the copyright in the Contribution. To the extent that the

 NGRS in the same terms as set out herein;

 - c. Nothing in the Contribution is obscene, defamatory, libellous, violates any right of privacy or infringes any intellectual property rights (including without limitation copyright, patent or trademark) or any other human, personal or other rights of any person or entity or is otherwise unlawful:
 - d. Nothing in the Contribution infringes any duty of confidentiality or non-disclosure which the Contributor may owe to anyone else or violates any contract, express or implied, to which the Contributor is a party; and
 - e. He shall not act in any manner which could be determined to be to the detriment of the NGRS.

These Conditions of Publication and any other agreements in which the Conditions of Publication are incorporated, shall be governed by and construed in accordance with English law and the Contributor hereby submits to the exclusive jurisdiction of the English courts, regardless of the nationality of the Contributor or the Country of origin of the Contribution.
